About the Climate Governance Initiative

The Climate Governance Initiative (CGI) is a non-profit, driven by a global community of Non-Executive Directors focused on making climate a boardroom priority. We build on the World Economic Forum's <u>Principles for Effective Climate Governance</u>.

CGI's global network of board directors, organised into 33 regional and national Chapters across 73 countries, offers unique insights into effective climate governance, through learning and sharing of best practice.

- We deliver effective climate governance content through courses, events, networking, and a Climate Governance Hub of information to help board members implement the World Economic Forum's *Principles for Effective Climate Governance*.
- We strengthen the network by helping Chapters to build a robust community of climate board leaders, advocates and supporting partners, focusing funding and partnership to deepen our impact.
- We drive focused, impactful growth by concentrating on the most critical economies to increase our global climate impact. We work with global partners, including the World Economic Forum, International Finance Corporation, European Bank for Reconstruction and Development, Deloitte, BCG and Egon Zehnder.

Initially hosted by Hughes Hall (a College of the University of Cambridge), the CGI is now part of Chapter Zero Alliance, a charity registered in England and Wales.

Internship purpose

We are seeking a motivated Summer Intern to assist in updating the Principles for Effective Climate Governance developed by the World Economic Forum in collaboration with the Climate Governance Initiative. This position will involve close collaboration with our partners at the World Economic Forum and Deloitte and is a fantastic opportunity to work with an important knowledge partner.

The intern will support various tasks, including desktop research, benchmarking, nature governance, planning chair interviews, and organising workshops. This role requires a keen interest in climate governance and sustainability, strong analytical skills, and excellent organisational abilities.

The primary goal of updating the Climate Governance Principles is to enhance the framework to better address current and emerging climate challenges. This update aims to integrate nature governance, recognising the interconnectedness of climate and natural ecosystems. By incorporating nature governance, we seek to promote biodiversity, sustainable land use, and ecosystem resilience alongside our climate objectives.

Role responsibilities

- Conduct desktop research on climate governance trends and best practices.
- Benchmark existing climate governance frameworks against industry standards.
- Assist in developing nature governance strategies.
- Plan and coordinate interviews with chairs and key stakeholders.
- Organise and facilitate workshops to gather insights and feedback.

Any specific outputs/deliverables

Desktop research, planning interviews, organising and facilitating workshops.

Mentoring and feedback

In addition to gaining valuable experience, developing an understanding of climate governance from a global perspective and contributing to the development of a critical knowledge resource, this internship will provide useful mentorship and networking opportunities both with experts at CGI and the World Economic Forum. The Forum Lead

will offer guidance and answer questions throughout the project, and you will also have a direct link into our Knowledge Exchange team at CGI.

This is a unique opportunity to gain valuable mentoring and work experience with a high-performing team of professionals working across chapter engagement, knowledge exchange, communications, administration, and at the executive level.

Feedback will be provided following regular progress reporting updates identified within the internship period. There will be regular check-ins to discuss their progress, address any questions or concerns and provide guidance on tasks. These meetings can also serve as opportunities for the interns to share their insights and findings. The meetings will provide feedback on work done: feedback on the intern's work regularly (weekly), focusing on what they are doing well and areas for improvement.

While this internship can be undertaken remotely, you will also have the opportunity to meet other interns within the programme.

Screening Check Requirements

Any offer will be subject to Chapter Zero Alliance verifying that you are eligible to work in the UK. If you are invited to interview, you will be asked to bring original documents from List A or List B (below) and a copy will be taken; alternatively, if you hold a 'digital immigration status', your Share Code will be required to access this status online.
